With correct management and feeding of this large-framed goose you will achieve exceptionally good weights, low conversion ratio and an excellent finish, however, weights will vary depending on management, environmental and weather conditions.

Whilst every precaution is taken, we accept no liability by reason of failure to deliver stock through any cause such as infertility of eggs, seasonal variation, fire, disease, accident, or through any cause not within our control. Delay or failure to deliver shall not entitle the buyer to damages. All quotations include carriage paid unless otherwise stated, and are subject to availability of stock on receipt of order.

## PLEASE NOTE

Should there be several dead on arrival contact your nearest veterinary surgeon, giving what particulars you can, and send us a copy of your letter. We usually send, free of charge, day-olds an extra one free to every 50 supplied, growers one free per 100. But this is no guarantee it will be done and customers must not consider it is their right to receive free goslings. If the extras only are dead, these are not replaced.

## PRICES

Prices are subject to revision at any time should production costs make this necessary. Any such revision shall be brought to the notice of the purchaser who shall have as his sole remedy the option (to be exercised in writing within seven days of being notified of the revision) of cancelling his contract.

## NOTIFICATION OF CANCELLATION OF ORDER

Notification must be made in writing. We reserve the right to make a charge of 10% where orders are cancelled within 14 days of delivery / collection.
